From 2016 to 2018, Isabelle Loc was Senior Banker, in charge of strategic clients at BNP Paribas. She joined the BNP Paribas Group in 2010, within CIB's Global Equity & Commodity Derivatives teams, before being appointed Secretary to the Group's Executive Committee in 2013. Isabelle Loc began her career with McKinsey & Company. She is a graduate of Ecole Polytechnique and Columbia University.
